Notes:

- If a full-time faculty member wishes to hold a concurrent position off-campus, their part-time employer must complete and send the application form to seek permission from the National Taiwan University (NTU) if the employer has not set an official letter to the NTU to request consent. If the part-time employer does send an official letter to NTU requesting consent, the Personnel Office shall solicit the opinion of the full-time faculty member regarding the request, whereupon it will be approved in accordance with relevant administrative procedures.
- 2. Each application can only be used for one concurrent position. The form must be completed accurately to facilitate the reviewing process. Applicants shall be held solely responsible for any inaccurate information contained therein.
- 3. Full-time faculty members (research fellows) shall get the written consent of NTU before taking on a concurrent position off-campus. Failure to comply shall result in the part-time wages earned by the faculty member during the violation period being collected by NTU and incorporated into the University Endowment Fund.
- 4. A full-time faculty member's part-time work must not affect their job at NTU. Additionally, any such faculty member must meet NTU's basic teaching hour and job requirements (this rule shall not apply to faculty members on leave or temporary transfer).
- 5. Full-time faculty members applying to work part-time at for-profit organizations or bodies must have their applications approved by their respective Academic Program Affairs Meeting. Once approved, the respective college will evaluate the application. Should the application meet the set standards, it will be submitted to NTU for final approval.
- 6. Full-time NTU faculty members (including those who also serve as managers) who wish to take on a concurrent position at a for-profit organization while representing the shares held by NTU in that organization must submit their applications to the NTU review team for review. Upon passing the review, the application shall be submitted to the president. The applicant can only begin part-time work upon the president's approval.
- 7. Professors on sabbatical wishing to take on a concurrent position outside of a research project shall first receive the consent of the Faculty Evaluation Committee of their associated unit.
- 8. A summary of the regulations governing faculty members working part-time at for-profit organizations or bodies is as follows:
 - (1) Faculty members concurrently serving as a director, supervisor, or independent director of a for-profit organization or body with which NTU has established an industry-academia partnership (including foreign companies located overseas or in Hong Kong or Macau) shall hold one of the following positions:
 - a) Non-shareholding director or supervisor appointed by the competent authority or selected by the board of directors and approved by the competent authority in accordance with the Securities and Exchange Act or Futures Trading Act.
 - b) Independent director of a state-owned enterprise, exchange- or OTC-listed company, or an unlisted public company for which the board of directors or shareholders' meeting has agreed (via resolution) to apply for listed status.
 - c) Independent director of a subsidiary (e.g., bank, stock company, insurance company, or integrated securities firm) whose shares are held entirely by a financial holding company.
 - d) 4. Independent director of a primary exchange- or OTC-listed foreign company in Taiwan, or unlisted foreign company for which the board of directors or shareholders' meeting has agreed (via resolution) to apply for primary exchange- or OTC-listed foreign company status.
 - (2) For faculty members concurrently holding the position of director or supervisor at for-profit organizations or bodies of which government agencies/institutions or NTU hold shares, the government agencies/institutions or NTU shall appoint a faculty member to represent the shares the government agencies/institutions or NTU hold in the enterprise or organization in accordance with the law.
 - (3) Faculty members working part-time on a research project at a government agency/institution shall work solely on said research project.
 - (4) Faculty members working part-time on a task force or other temporary organization at a state-owned institution shall only hold the part-time position created to meet the specified temporary need.
 - (5) Faculty members wishing to work at an academic journal publisher (including foreign companies located overseas or in Hong Kong or Macau) or a publisher that edits textbooks or teaching books/manuals in accordance with the curriculum guidelines established by the Ministry of Education may only work part-time as a consultant or editor.
- 9. When a faculty member is selected as an independent director as described in the preceding article, the for-profit organization or body where the faculty member works shall make a resolution at the first board meeting following the shareholders' meeting to sign the Industry-Academia Collaboration and Academic Feedback Mechanism Agreement with NTU within 3 months starting from the day the for-profit organization or body elected the faculty member to be an independent director. The resolution will be retroactively effective starting from the day the faculty member was elected, and a letter shall be sent to notify NTU. Those who meet this requirement will have the part-time work they did within 3 months starting from the day they were selected deemed lawful. Conversely, if the for-profit organization or bodies cannot make a resolution that goes into effect retroactively regarding the faculty member's appointment at the first board meeting following the shareholders' meeting, the faculty member's part-time work will not be deemed valid. Failure to sign the Industry-Academia Collaboration and Academic Feedback Mechanism Agreement at the appointed time will result in the letter of agreement for the part-time work not going into effect starting from the day after the end

- of the 3-month period. Faculty members wishing to hold a concurrent position related to their post as an independent director shall submit an application in accordance with relevant regulations. The validity of the duties performed over the aforementioned 3-month period will be the same as for an independent director.
- 10. Faculty members wishing to hold a concurrent position as a director of a new biotech drug company shall meet one of the following criteria:
 - (1) Possession of the company's primary technology for developing and manufacturing new drugs to be administered to humans, animals, or plants.
 - (2) Possession of the company's primary technology for developing, manufacturing, implanting, or inserting Class III high-risk medical devices into humans.
- 11. Faculty members may concurrently hold the following positions in an enterprise, institution, group, or start-up in accordance with the Regulations on Researchers' Dual Positions and Contribution of Technology as an Equity Investment:
 - (1) A position related to the faculty member's field of study that has no business operations.
 - (2) Holders of the primary R&D technology of a start-up company who may hold a concurrent post as the company director.
- 12. Faculty members may not take on the following part-time positions:
 - (1) Professional, legally-regulated occupations such as a lawyer, accountant, architect, or technician. However, this rule shall not apply to those who work in the aforementioned occupations if the affairs (of a social welfare nature) that they engage or participate in take place during their off-duty hours.
 - (2) Chairman of the board or other permanent administrative position in a private school.
 - (3) Positions at schools in Hong Kong or Macau established by or registered to the local competent authority that may compromise Taiwan's national standing or national security.
- 13. If a concurrent position requires the faculty member to work regular hours, the total number of work hours may not exceed eight hours per week. However, during winter and summer vacations, faculty members may apply to increase the number of part-time work hours to a maximum of 40 hours per week.
- 14. For faculty members working part-time (including administrative positions) at a public college or university, their maximum number of part-time positions and maximum salary are not subject to the restrictions of the Part-Time Payment Standards for Concurrently Serving Military, Civil and Teaching Personnel (i.e., a maximum of two concurrent positions and a maximum part-time salary of NT\$17,000). Part-time salaries or wages shall be paid indirectly through the full-time agency/institution/school and may not be paid directly by the part-time agency/institute/school.
- 15. Rules governing faculty members with concurrent administrative duties at NTU:
 - (1) The faculty members must comply with regulations for part-time civil servants such as the Public Functionary Service Act and Regulations Governing Civil Servants Concurrently Serving as Directors or Supervisors at Government Invested or Reinvested Private Business Institutions, Foundations, and Corporations.
 - (2) Except for mandatory part-time positions, a civil servant may concurrently hold no more than 2 positions as a director or supervisor at a public or private business or as a director or supervisor or other position at or above the level of CEO or deputy secretary general at a foundation.
 - (3) In principle, unless otherwise specified by law, full-time faculty members with administrative duties may not concurrently hold the position of external independent director or supervisor of a private company in their capacity as a private individual.
 - (4) Unless otherwise specified by law or if the faculty member has already applied to retain the position without pay in accordance with the Civil Service Regulations on Retaining Positions Without Pay, a faculty member may not concurrently serve as a chairman of the board or deputy chairman of the board at a government reinvested business.
 - (5) The scope and approval process for faculty members concurrently holding a administrative position shall be handled in accordance with the Public Functionary Service Act. Articles 3–6 and 10 of the Principles Governing Full-Time Faculty Members Working at Public Schools of All Levels shall not apply.

- 12. Civil servants may concurrently serve as directors or supervisors at state-owned institutions or enterprises (of which the government holds shares) while representing shares owned in accordance with the relevant laws.
- 13. Full-time faculty members concurrently serving as the director of a public college or above (of which the government or NTU holds shares) may serve as the director or supervisor of a private company while representing the shares held by the government or NTU; the faculty member may work in investment, university affairs, or research-related companies described in Article 7.1 of the National University Endowment Fund Establishment Act. However, Official Letter Bu Fa (1) Tzu No. 0912160938 issued by the Ministry of Civil Service on July 18, 2002 stipulates that full-time faculty members concurrently serving as directors may not work as external independent directors or supervisors at private companies as private individuals.
