The aforementioned agencies/institutions may add or make adjustments to the form to meet their operational needs or better suit the nature of their work.

If the part-time work does not fall under the scope of Articles 14, 14-2, and 14-3 of the Act (e.g., those working in a licensed occupation, those concurrently serving on a task force for or at a position to meet a temporary need for a government agency/institution or non-profit enterprise or group), the agency/institution may decide whether it is necessary for the employee to fill in this form.
- 4. During the training of civil servants enlisted via examination, the personnel department (or training agency) of the service agency shall have civil service trainees study the contents of this questionnaire and complete it at the end of the training period.
- 5. If a review by the responsible authority determines that a civil servant has committed a business or investment violation as stipulated in Article 13 of the Act or has violated the part-time regulations in Articles 14, 14-2, and 14-3 of the Act, the civil servant shall be penalized in accordance with Article 13, Paragraph 4 and Article 22 of the Act.
