

Consent Form for Educators Applying for Paid-in Civil Service Pension Fund Fee Refunds

The resignation of I, the undersigned, will take effect on YYYY/MM/DD.

The rules governing the refunding of paid-in Civil Service Pension Fund fees have been explained to me by personnel of the Personnel Office, National Taiwan University as follows:

1. If I no longer serve as an educator, I may fill out an Application for the Refunding of Paid-in Civil Service Pension Fund Fees (my signature and stamp will be required) within 10 years of the date of my resignation. I will submit the application form along with my Employment Separation Certificate and a photocopy of my passbook cover (with either the Bank of Taiwan, First Bank, or Taiwan Cooperative Bank) to the Personnel Office's Retirement, Pension, and Insurance Division so that the Civil Service Pension Fund management authority can process my application. Failure to do so within the preceding 10-year period will result in the forfeiture of the principal and interest from my paid-in Civil Service Pension Fund fees. However, if I once again serve as a civil servant at a later date, my previous years of service in which the Civil Service Pension Fund fees that I have forfeited may be added to my years of service at retirement according to relevant retirement laws and regulations, or may be added to my current years of service when I apply for a refund of my paid-in Civil Service Pension Fund fees.
2. If I have already collected the Civil Service Pension Fund fee refund, my previous years of service may not be added to my current years of service (when calculating the Civil Service Pension Fund fee refund that I am eligible for) should I become an educator once again. Additionally, I may not apply for a make-up payment of Civil Service Pension Fund fees already refunded to me.

3. Educators who change employment to work in public units, private units, or private schools after their resignation and who have applied for retirement in accordance with the *Labor Standards Act*, *Labor Pension Act*, *Private School Retirement and Compensation Act*, or other relevant regulations may, in accordance with Article 10 of the *Act Governing Retirement, Severance, and Bereavement Compensation for the Teaching and Other Staff Members of Public Schools*, apply to the Civil Service Pension Fund management authority for a refund of the principal and interest of their paid-in Civil Service Pension Fund fees as late as 6 months from the day that they turn 65. In such cases, the aforementioned 10-year prescription will not apply.
4. If I do not request a refund of my paid-in Civil Service Pension Fund fees, and I have served as an educator for over 5 years, my years of service may be retained and I may apply for the refund as late as 6 months from the day that I turn 65.

I hereby declare that I fully understand my rights and interests, have no objections, and agree not to apply for my Civil Service Pension Fund fee refund at this time in accordance with relevant regulations.
