Appeal Procedures for Contract Employees in Sponsored Projects

Notes:

- 1. In the event that the project personnel applies for mediation or files an appeal with a competent authority for labor affairs, the University appeal process shall cease, and the mediation shall be executed by the competent authority. The principal investigator shall be present to explain the situation, and comply with the competent authority's decision. The project execution unit may send staff representative(s) to accompany the principal investigator.
- 2. In the event that the dispute or labor inspection matter involves the overall policy or regulations of the University, the Personnel Office or other relevant units may send staff representatives to attend the mediation.
