Chapter I General Provisions

(Statutory basis)

Article 1 National Taiwan University (NTU or “the University”) establishes the *NTU Organizational Charter* (“the Organizational Charter”) in accordance with Article 36 of the *University Act*.

(Purpose)

Article 2 The purpose of the University lies in the search for truth, academic research, talent cultivation, cultural enhancement, and service to humanity.

(Establishment of campuses, branches, and divisions)

Article 3 NTU may establish campuses, branches, and divisions as needed.

(University systems)

Article 4 NTU may, by resolution of the University Council, establish university systems or inter-university research centers with other academic institutions. Regulations governing the organization and operation of both the university systems and inter-university research centers established under the preceding paragraph shall be jointly stipulated by NTU and the partnering institutions and will be implemented upon passage by the University Council and submission to the Ministry of Education for reference.

(University mergers)

Article 5 NTU may, by resolution of the University Council, merge with other academic institutions. Merger plans as mentioned in the preceding paragraph shall be jointly formulated by NTU and the institution to be merged with and will be implemented after passage by the University Council and approval by the Ministry of Education.

Chapter II Organization

Section I President and Executive Vice Presidents

(Duties and responsibilities, qualifications, and term of office of the President)

Article 6 NTU shall appoint one President, who represents the University and is responsible for handling university affairs and development. The qualifications required for the position of President of the University shall be in accordance with the applicable laws. The position may be filled by a foreign individual and is not restricted by the provisions concerning nationality and employment in the *Nationality Act* and the *Employment Service Act*. The President shall be appointed to a four-year term and may be reappointed to two ensuing terms. In principle, the term of office starts on August 1 or February 1.

(Appointment and reappointment procedures for the position of President of the University)

Article 7 To select a new President, the Presidential Selection Committee shall be constituted in accordance with the Organizational Charter for presidential selection. The selection shall be submitted to the Ministry of Education for appointment. The University Council shall decide on the reappointment of the President of the University one full year in advance of the end of the President's term of office. If the President does not wish to continue their term, they shall make their intent known to the University Council at least 14 months before the end of the President's term of office, after which the selection of a new President will commence in accordance with the Organizational Charter. If the President wishes to continue their term, they shall apply for an evaluation by the Ministry of Education at least 14 months before the end of their term of office. Before a meeting of the University Council is convened to discuss the President's reappointment, the President shall submit a written university

performance report to the University Council, and shall recuse themselves from discussion and voting on the motion for their reappointment.

The first reappointment of the President may only be passed with the majority of the University Council members in concurrence; the second reappointment may only be passed with two-thirds or more of the University Council members in concurrence. If the reappointment of the President is not passed, the selection of a new President shall be carried out in accordance with the Organizational Charter.

The University Council shall take into account the Ministry of Education's evaluation results when deliberating over the motion for reappointment of the President.

For the reappointment of a President who was appointed prior to the implementation of an amendment to the Organizational Charter, the provisions of the Organizational Charter shall be observed.

(Presidential Selection Committee)

Article 8 The NTU Presidential Selection Committee shall be formed 10 months prior to the end of the President's term or within 2 months after the office of the President falls vacant with cause.

The Presidential Selection Committee shall consist of 21 members including 9 NTU representatives chosen by the University Council, 9 alumni representatives and lay persons recommended by NTU, and 3 representatives appointed by the Ministry of Education. The Committee's chair shall be elected from among the members. The directives governing the Committee's organization and operation will be stipulated separately by the University Council.

The Presidential Selection Committee shall complete the selection process 3 months prior to the end of the President's term or within 7 months after the office of the President falls vacant.

(Reporting obligations of the President)

Article 9 The President shall propose a four-year work plan during the University Council meeting held in the semester in which they take office. Starting in the second academic year of their term, the President shall give an annual report during the University Council meeting in the fall semester of every academic year.

(Resignation of President, interim duties in the event of vacancy of office, and re-selection of President)

Article 10 If the President is found to have committed a major legal violation or negligence of duty, University Council members may propose the dismissal of the President. If the proposal is made by one quarter or more of the council members and passed with a two-thirds vote of a quorum, three-fourths of the council members present, the University Council shall pass the dismissal and request approval from the Ministry of Education.

If the office of the President falls vacant or if the President is removed from office by the Ministry of Education in accordance with the preceding paragraph, an interim President shall be selected in accordance with the

presidential succession order, and approval from the Ministry of Education shall be obtained. The Presidential Selection Committee shall also be formed to elect a new President in accordance with the Organizational Charter.

If the new President is unable to take office, an interim President shall be selected in the order of presidential succession, and approval from the Ministry of Education shall be obtained. The original Presidential Selection Committee shall continue the selection of a new President.

(Number, qualifications, term length, and resignation of Executive Vice Presidents)

Article 11 The President shall appoint 2 to 3 Executive Vice Presidents to assist the President in the handling of university affairs.

Executive Vice Presidents shall be full-time NTU professors.

In principle, the term of office of Executive Vice Presidents shall coincide with that of the President.

Executive Vice Presidents are not guaranteed to have or limited by a fixed term of office, and shall be removed from office with the appointment of a new President.

Section II Academic Units

(Colleges, departments/divisions, graduate institutes, and degree programs)

Article 12 NTU shall establish colleges, departments/divisions, and graduate institutes, as well as inter-collegiate, inter-departmental, and inter-institutional degree programs. For more details, please refer to Appendix 1: Organizational Structure of National Taiwan University Colleges, Departments/Divisions, Graduate Institutes, and Degree Programs) of the Organizational Charter.

(Establishment of graduate schools)

Article 12-1 NTU shall establish the Graduate School of Advanced Technology in accordance with the *Act for National Key Fields Industry-University Cooperation and Skilled Personnel Training*. The organizational regulations for the graduate school shall be stipulated separately.

(Organizational changes to colleges, departments/divisions, graduate institutes, and degree programs)

Article 13 Plans for the establishment of, changes to, mergers of, and closing of NTU colleges, departments/divisions, graduate institutes, or degree programs shall be carried out through resolutions of the University Council and with approval from the Ministry of Education. The attached Appendix 1 of the Organizational Charter shall be amended accordingly after receiving approval from the Ministry of Education and submitted to the University Council for reference.

Regulations governing the application procedures for the establishment of, changes to, mergers of, and closing of NTU colleges, departments/divisions, graduate institutes, or degree programs shall be stipulated by the Office of Academic Affairs and implemented after passage by the University Council.

(Heads and staff of colleges, departments/divisions, graduate institutes, and degree programs)

Article 14 Each college shall appoint one dean to handle college affairs; each department (division) shall appoint one chair to handle department (division) affairs; each independently established graduate institute shall appoint one director to handle institute affairs; and each degree program shall appoint one director to handle degree program affairs.

NTU colleges, departments/divisions, and graduate institutes shall appoint staff members in accordance with the University's staffing chart.

(Appointment standards for associate heads of colleges, departments/divisions, graduate institutes, degree programs, and other academic units)

Article 15 Colleges that meet any of the following criteria may appoint one associate dean with the approval of the President:

1. Colleges with four or more departments/divisions or graduate institutes
2. Colleges with 100 or more full-time faculty members
3. Colleges with 1,000 or more students

In addition to meeting the criterion set forth in Subparagraph 4, colleges that meet any two of the following criteria may appoint one additional associate dean:

1. Colleges with eight or more departments/divisions or graduate institutes
2. Colleges with 200 or more full-time faculty members
3. Colleges with 3,000 or more students
4. Colleges for which an additional associate dean is deemed necessary by the Administrative Meeting due to heavy workloads or other special circumstances.

Departments/divisions, graduate institutes, and degree programs that meet any of the following criteria may appoint one head with the approval of the President:

1. Departments/divisions, graduate institutes, or degree programs with 30 or more full-time faculty members
2. Total student number of 500 or more
3. An additional associate dean may be deemed necessary by the Administrative Meeting due to heavy workloads or other special circumstances.

Departments/divisions, graduate institutes, and degree programs with 60 or more full-time faculty members and a total student number of 1,000 or more may appoint one more additional associate head.

Departments/divisions, graduate institutes, and degree programs that have appointed (an) associate head(s) in accordance with the four preceding paragraphs but that are no longer eligible to appoint such staff member(s) shall, with the approval of the President, rescind the appointment of the associate head(s) starting in the following academic year.

The School of Professional Education and Continuing Studies, academic units not associated with any college, and other university-level research centers with heavy workloads or other special circumstances may appoint an additional associate dean if deemed necessary by the Administrative Meeting.

The appointment or changes of associate head(s) may be implemented after the University's staffing chart is amended accordingly and submitted to the

Ministry of Education for approval.

(Selection of college deans)

Article 16 Each college shall form a selection committee which will call for candidate recommendations, select the new college dean from among the candidates, and request the President to approve the appointment.

The President shall make appointments of deans of newly established colleges. College deans must qualify as professors.

In principle, college deans shall be appointed to three-year terms and may be reappointed to one ensuing term. The reappointment of a college dean shall be decided upon by a certain specified number of voting members of the faculty and College Affairs Meeting of the college in question or in accordance with the procedures set forth in the college's selection regulations; once the reappointment is passed, a request for the dean's reappointment shall be submitted to the President for approval.

If, for compelling reasons, the dismissal of a college dean is agreed upon by a certain specified number of voting members of the faculty or College Affairs Meeting of the college in question, the President may remove the dean from office before the end of the dean's term.

The selection, reappointment, and dismissal procedures of college deans, as well as the organization and operation of selection committees and other matters of compliance shall be set forth in the colleges' dean selection regulations in accordance with the provisions above. Such regulations shall be stipulated by the College Affairs Meeting of each college and will take effect upon passage by the Administrative Meeting.

(Selection of heads of schools, departments/divisions, and graduate institutes)

Article 17 For school deans, department/division chairs, and directors of graduate institutes, each school, department/division, or graduate institute shall form a selection committee to select its new dean, chair, or director. The decision shall then be submitted to the dean of the unit's associated college, who shall forward it to the President for approval of the appointment.

For newly established schools, departments/divisions, and graduate institutes, the dean of their respective college shall make the appointment of the heads of these academic units after obtaining approval from the President.

Department/divisions/division chairs and directors of graduate institutes must qualify as associate professors or professors; school deans must qualify as professors.

In principle, school deans, department/division chairs, and directors of graduate institutes shall be appointed to three-year terms and may be reappointed to one ensuing term. The reappointment of a school dean, department/division chair, or director of graduate institute shall be decided upon by a certain specified number of voting members of the faculty and Department/Division/Institute Affairs Meeting of the academic unit in question or in accordance with the procedures set forth in the unit's selection regulations; once the reappointment is passed, a request for the reappointment shall be submitted to the President in accordance with administrative procedures for approval.

If, for compelling reasons, the dismissal of a school dean, department/division chair, or director of graduate institute is agreed upon by a certain specified number of voting members of the faculty or Department/Division/Institute Affairs Meeting of the academic unit in question, the dean of the associated college may remove the school dean, department/division chair, or director of graduate institute from office before the end of the latter's term after informing the President.

The selection, reappointment, and dismissal procedures of school deans, department/divisions/division chairs, and directors of graduate institutes, as well as the organization and operation of selection committees and other matters of compliance shall be set forth in the units' own selection regulations in accordance with the provisions above. Such regulations shall be stipulated by the School/Department/Division/Institute Affairs Meeting of each unit and will take effect upon passage by the College Affairs Meeting of their associated college.

(Selection of directors of degree programs)

Article 18 The directors of degree programs shall be appointed by the President from among the heads of the academic units that jointly established the degree programs (deans, associate deans, department/division chairs, heads, or directors of colleges, departments/divisions, graduate institutes, Center for General Education, Athletic Department) or from among faculty members with expertise in a field related to the degree program who hold the rank of associate professor or professor.

In principle, directors of degree programs shall be appointed to three-year terms and may be reappointed to one ensuing term. Reappointments shall be made by the President after the incumbent directors are consulted.

If, for compelling reasons, the dismissal of a director of degree program is required, the President may remove the director of degree program from office before the end of the latter's term.

(Selection of associate heads of colleges, departments/divisions, graduate institutes, and degree programs)

Article 19 Associate college deans, associate department/division chairs, associate directors of graduate institutes, and associate directors of degree programs shall be appointed by the President at the request of the respective college dean, department/division chair, or director of graduate institute or degree program. The reappointment procedures shall be the same as the appointment procedures and these associate positions shall be reappointed upon the removal of their respective college dean, department/division chair, or director of graduate institute or degree program.

If, for compelling reasons, the dismissal of an associate college dean, associate department/division chair, associate director of graduate institute, or associate director of degree program is required, the associated college dean, department/division chair, or director of graduate institute or degree program may request that the President remove the aforementioned associate head from office before the end of the latter's term.

Article 19-1 The appointment of interim heads of academic units shall be in accordance

with the following procedures:

1. If the position of head of an academic unit becomes vacant, the position will be temporarily filled (for up to one year) by an adjunct appointee qualified for interim duties.
2. If the head of an academic unit takes an unpaid leave of six months or less, their position will be temporarily filled by an adjunct appointee qualified for interim duties or a faculty member of the same academic unit.
3. If the head of an academic unit takes a leave of absence, their position will be temporarily filled by an appointee qualified for interim duties. However, for leaves of absence of six months or less, the position may be filled by a faculty member of the same academic unit.

If the position of associate head of an academic unit becomes vacant or if the associate head goes on an unpaid leave or leave of absence of six months or less, the position may be temporarily filled by a faculty member of the same academic unit. However, the length of the interim appointment may not exceed one year, and the appointee must be legally qualified to perform the interim duties.

(Establishment of the School of Professional Education and Continuing Studies)

Article 20 NTU shall establish a School of Professional Education and Continuing Studies, the organizational regulations of which shall be stipulated separately by the University Council.

The duties and operation of the School of Professional Education and Continuing Studies shall not be subject to the college-related provisions of the Organizational Charter.

Section III Administrative Units

(Administrative units)

Article 21 The University shall establish the following administrative units and appoint heads of these units:

1. Office of Academic Affairs: 1 Vice President for Academic Affairs and 1-2 Deputy Vice Presidents for Academic Affairs shall be appointed. The office shall be responsible for student recruitment and admissions, curriculum development, educational development, and other academic affairs.
2. Office of Student Affairs: 1 Vice President for Student Affairs and 1-2 Deputy Vice Presidents for Student Affairs shall be appointed. The office shall be responsible for student assistance, extracurricular activities, national defense education and military service administration, guidance and career counseling, guidance for overseas and mainland Chinese students, health care and medical services, student counseling, administration of the Student Activity Center and student dormitories, and other student affairs.
3. Office of General Affairs: 1 Vice President for General Affairs and 1-2 Deputy Vice Presidents for General Affairs shall be appointed. The office shall be responsible for handling documentation, general services,

monetary services, construction and maintenance, property management, procurement, facilities services, faculty and staff housing services, and other general affairs.

4. Office of Research and Development: 1 Vice President for Research and Development and 1-2 Deputy Vice Presidents for Research and Development shall be appointed. The office shall be responsible for planning and promoting academic research, research projects, technology transfers, industry-academic collaborations, and research ethics reviews, as well as handling other affairs related to research and development.
5. Office of International Affairs: 1 Vice President for International Affairs and 1 Deputy Vice President for International Affairs shall be appointed. The office shall be responsible for planning and managing international collaborations and exchanges, recruiting and counseling international students, and assisting foreign scholars visiting NTU.
6. Office of Financial Affairs: 1 Vice President for Financial Affairs and 1 Deputy Vice President for Financial Affairs shall be appointed. The office shall be responsible for handling financial plans, funding, and fundraising, as well as the development of, management of, and investment in new business endeavors.
7. NTU Library: 1 Head Librarian and 2 Deputy Head Librarians shall be appointed. The NTU Library shall be responsible for collecting and preserving teaching and research materials as well as providing information and services.
8. Office of the Secretariat: One Secretary-General shall be appointed. The Secretariat shall be responsible for handling meetings, public relations, alumni outreach, and miscellaneous affairs.
9. Office of Internal Audits: One Director shall be appointed. The office shall be responsible for the internal control and auditing of the University Endowment Fund.
10. Computer and Information Networking Center: One Director shall be appointed. The center shall be responsible for providing the computer equipment, internet/communication services, etc. required for teaching, research, and administrative work.
11. University Press: One Director shall be appointed. The University Press shall be responsible for editing, publishing, selling, and issuing academic publications, as well as providing intellectual property consulting services.
12. Environmental Health and Safety Center: 1 Director and 1 Deputy Director shall be appointed. The center shall be responsible for environmental protection, occupational safety and health, and security matters.

Deputy heads of the administrative units listed in the preceding paragraph shall be appointed in accordance with the Ministry of Education's Determination Criteria for the Appointment of Deputy Heads in First Level Administrative Units of Universities.

NTU may establish administrative centers for the purpose of teaching, research, or promotional activities with the approval of the University

Council.

Article 21-1 The University shall establish an Accounting Department, which shall appoint 1 Director, 1 Senior Executive Officer, 1 Secretary, and other staff members (Division Directors, Senior Clerks, and Clerks), and shall be responsible for handling budgets, accounting, and statistics.

Article 21-2 The University shall establish a Personnel Office, which shall appoint 1 Director, 1 Senior Executive Officer, 1 Secretary, and other staff members (Division Directors, Senior Clerks, Assistants, and Clerks), and shall be responsible for personnel management in accordance with the law.

(Selection and qualifications of heads and deputy heads of administrative units)

Article 22 Apart from the Head Librarian of the NTU Library and the Directors of the Accounting Department and Personnel Office, the heads of all NTU administrative units listed in Articles 21, 21-1, and 21-2 shall be appointed by the President from among NTU instructors and researchers. However, the position of the Secretary-General of the Office of the Secretariat may also be filled by a staff member.

The Head Librarian of the NTU Library shall be appointed by the President from among NTU instructors and researchers who demonstrate the requisite professional knowledge and skills or the staff members of the NTU Library.

The appointment of the Directors of the Accounting Department and Personnel Office shall be carried out in accordance with the applicable laws.

The deputy heads of administrative units shall be selected by the unit head of their respective unit from among NTU instructors and researchers. The selected candidates shall be appointed by the President and shall be removed from office with the appointment of a new unit head.

(Term length and resignation of heads of administrative units)

Article 23 Unless removed from office by the President, all heads of administrative units appointed by the President shall serve 4-year terms and may be reappointed to 1 ensuing term.

The Vice President for Academic Affairs, Vice President for Student Affairs, Vice President for General Affairs, Vice President for Research and Development, Vice President for International Affairs, and Vice President for Financial Affairs shall resign their offices when the President reaches the end of their term and a new President assumes office.

(Division of administrative units)

Article 24 NTU administrative units shall be divided into divisions, branch offices, departments, or centers. Each division, branch office, and center shall appoint one director and staff members. For more details on personnel appointments, please refer to Appendix 2 of the Organizational Charter: Organizational Structure of National Taiwan University.

Appendix 2 shall be passed by the Administrative Meeting, submitted to the University Council for reference, and submitted to the Ministry of Education

for approval.

Division Directors and Directors shall be appointed by the President from among NTU instructors and researchers who hold the rank of assistant professor or higher. The position of Division Director may also be filled by staff members.

Section IV Affiliated organizations and non-college associated academic units, research centers, libraries/museums/galleries, graduate institutes, and committees

(Affiliated organizations of NTU and its colleges)

Article 25 The affiliated organizations established by NTU and its colleges are listed in Appendix 3: Organizational Structure of the Affiliated Organizations of National Taiwan University and its Colleges.

The establishment of, changes to, and closing of affiliated organizations shall require passage of a resolution by the University Council and approval from the Ministry of Education. The attached Appendix 3 of the Organizational Charter shall be amended accordingly after receiving approval from the Ministry of Education and submitted to the University Council for reference.

Unless otherwise stipulated by law, the organizational regulations of affiliated organizations established by NTU and its colleges shall be formulated by the University Council.

(Appointment of heads of affiliated organizations)

Article 26 The heads at various levels of the affiliated organizations established by NTU and its colleges shall be appointed in accordance with the organizational regulations of the respective affiliated organization.

(Non-college-associated academic units)

Article 27 NTU shall establish a Center for General Education as a non-college associated academic unit. The center shall appoint 1 Director, 1 Deputy Director, and faculty and staff members, and shall be responsible for the planning and review of general core courses, liberal education courses, physical education courses, and teacher training courses.

In order to carry out appropriate physical education and sports science research, sports activities, sports facility and equipment management, and other sports-related matters, NTU shall establish an Athletic Department, which shall appoint one Director and instructors, coaches, and staff members. NTU shall establish a Center for Teacher Education to handle matters related to secondary school teacher education programs. The Center shall appoint one Director and faculty and staff members. If deemed necessary and with the approval of the President, one additional Deputy Director may be appointed in accordance with the applicable laws.

(Selection, qualifications, and term of office of the heads and deputy heads of non-college associated academic units)

Article 28 Directors of centers that are non-college-associated academic units shall be

appointed by the President from among full-time NTU instructors who hold the rank of associate professor or higher; deputy directors of these centers shall be appointed from among instructors by the directors of their respective centers, who shall request approval from the President.

The directors of these centers shall be appointed to four-year terms and may be reappointed to one ensuing term.

Deputy directors of centers that are non-college-associated academic units shall be removed from office with the appointment of new directors of their respective centers.

(Research centers, exhibition halls, research institutes, and committees)

Article 29 The research centers, exhibition halls, research institutes, and committees established by NTU and its colleges are listed in Appendix 4: Organizational Structure of the Research Centers, Exhibition Halls, Research Institutes, and Committees of National Taiwan University and its Colleges.

NTU's establishment of, changes to, and closing of university-level research centers shall require passage of a resolution by the University Council.

Each university-level research center shall appoint one director. Each college-level research center, exhibition hall, research institute, and committee shall appoint one director, curator, head, or chair. If deemed necessary and with the approval of the President, additional Deputy Director(s) may be appointed.

College-associated research centers, libraries/museums/galleries, graduate institutes, and committees shall be subject to the supervision of the deans of their associated college.

(Selection, qualifications, and term of office of the heads and deputy heads of research centers, libraries/museums/galleries, graduate institutes, and committees)

Article 30 The Directors of university-level research centers shall be appointed by the President from among full-time NTU instructors who hold the rank of associate professor or higher or NTU researchers who hold an equivalent rank; Deputy Directors of these centers shall be appointed from among instructors or researchers by the Directors of their respective centers, who shall request approval from the President.

The directors, curators, heads, and chairs of college-level research centers, libraries/museums/galleries, graduate institutes, and committees shall be appointed, with approval from the President, by the Dean of their associated colleges from among full-time NTU instructors who hold the rank of associate professor or professor or NTU researchers who hold an equivalent rank; deputy directors, curators, heads, and chairs of these units shall be appointed from among instructors or researchers by the heads, who shall request approval from the Dean of the associated college and the President.

Deputy directors, curators, heads, and chairs of these units shall be removed from office with the appointment of new heads.

(Approval procedures for regulations governing the organization and operation of affiliated organizations, non-college-associated academic units, and research centers)

Article 31 Unless otherwise stipulated by law, regulations governing the organization

and operation of affiliated organizations, non-college-associated academic units, research centers, libraries/museums/galleries, graduate institutes, and committees shall be passed by the Administrative Meeting and submitted to the University Council for reference.

(Division of non-college-associated academic units and research centers)

Article 32 Non-college-associated academic units of NTU shall be divided into divisions, branch offices, departments, or centers. Each division, branch office, and center shall appoint one director and staff members. For more details on personnel appointment, please refer to Appendix 2 of the Organizational Charter: Organizational Structure of National Taiwan University.

The Center for General Education's *Regulations Governing the Establishment of the Center for Teacher Education* shall take effect after passage by the University Council and submission to the Ministry of Education for approval.

(Establishment of committees in accordance with the law)

Article 33 The University shall establish committees in accordance with the law.

Section V Staff

(Staff appointments)

Article 34 NTU units shall appoint staff members in accordance with the University's staffing chart.

The University's staffing charts for faculty and staff shall be stipulated in accordance with the law and submitted to the Ministry of Education for approval before being implemented. The staffing chart for staff shall also be submitted to the Examination Yuan for approval and reference.

(Staff titles)

Article 35 Staff members of NTU units shall be given the following titles:

1. Regular staff: Senior Executive Officer, Secretary, Technical Specialist, Division Director, Executive Officer, Counselor, Senior Social Worker, Senior Clerk, Social Worker, Senior Technician, Veterinarian, Assistant, Technician, Clerk, and Associate Clerk
2. Medical staff: Physician, Pharmacist, Senior Nurse, Dietician, Medical Technologist, Physical Therapist, Occupational Therapist, Medical Radiation Technologist, Counseling Psychologist, Clinical Psychologist, Nurse

The employment of sports coaches, technicians specializing in uncommon technologies, and other professional occupations stipulated by law are not subject to the restrictions set forth in the preceding paragraph. The qualifications requirements for technicians specializing in uncommon technologies shall be stipulated in accordance with Article 10, Paragraph 2 of the *Regulations Governing the Qualifications Requirements of Technicians Specializing in Uncommon Technologies*, which states that "after the amendment to these Regulations takes effect on August 2, 2001, public universities and colleges may no longer employ information technology

personnel. Existing information technology personnel employed before the amendment takes effect may retain their positions until their separation from their employer. The promotion of technology personnel shall be carried out in accordance with the original rules set forth in these Regulations prior to the amendment.”

The hierarchy of the titles listed in Paragraph 1 shall be stipulated in accordance with the Examination Yuan’s Tabulation of Grades.

The faculty member titles of the University’s affiliated organizations shall be stipulated in accordance with the organizational regulations of the respective organizations.

Chapter III Meetings

Section I University Council

(Composition of the University Council)

Article 36 NTU shall establish a University Council to deliberate and make official decisions on important matters concerning the University. The University Council shall consist of the President, Executive Vice Presidents, Vice President for Academic Affairs, Vice President for Student Affairs, Vice President for General Affairs, Vice President for Research and Development, deans, representatives of the heads of academic programs and non-college units, faculty representatives, researcher representative, teaching assistant representative, staff representatives, messenger/custodian representative, and student representatives.

The number of seats for the representatives listed in the preceding paragraph are as follows:

1. Representatives of the heads of academic programs and non-college units: The number of representatives appointed by each college or non-college unit shall be one-third of the total number of heads of the associated academic programs or non-college units. Decimal numbers shall be rounded to the nearest integer.
2. Faculty representatives: One-half of the representatives on the University Council shall be faculty representatives. Faculty representatives shall be elected from among the faculty members of the colleges and non-college units. The number of representatives elected by each college or non-college unit shall be in proportion to the total number of faculty members in that college or non-college unit.
3. One researcher representative
4. One teaching assistant representative
5. Eight staff representatives
6. One messenger/custodian representative
7. Student representatives: One-tenth of the representatives on the University Council shall be student representatives. The presidents of the Student Association, Student Congress, and Graduate Student Association shall be ex officio representatives; the remaining seats shall be filled by representatives selected from among the presidents of the college student associations. If there are any seats left for additional

student representatives, they shall be filled via an election held in accordance with the regulations stipulated by the Office of Student Affairs.

Regulations governing the appointment of representatives of the heads of academic programs and non-college units shall be stipulated by the respective College Affairs Meetings and non-college units. However, in principle, at least one person from each academic unit shall be appointed as a faculty representative or representative of the heads of their academic program.

The non-college units referred to in this article are the Center for General Education, Athletic Department, Center for Condensed Matter Sciences, and Center for Teacher Education.

Two-thirds of the faculty representatives must qualify as professors or associate professors.

The total number of University Council representatives shall conform with the minimum number of seats set forth in Paragraph 2 of this article.

(Election/selection and term length of University Council representatives)

Article 37 Faculty representatives on the University Council shall be elected by NTU colleges from among their faculty members. The number of seats assigned to each college shall be determined by the number of professors, associate professors, assistant professors, and lecturers in the college. Faculty representatives shall be appointed to a one-year term and may be reappointed to two ensuing terms.

Faculty representatives of non-college units shall be selected from among the faculty members of non-college units in accordance with the procedures set forth in the preceding paragraph. Faculty representatives shall be appointed to a one-year term and may be reappointed to two ensuing terms.

The researcher representative shall be elected from among all NTU researchers (including those of the affiliated organizations). The researcher representative shall be appointed to a one-year terms and may be reappointed to two ensuing terms.

The teaching assistant representative shall be elected from among all NTU teaching assistants. The teaching assistant representative shall be appointed to a one-year term and may be reappointed to two ensuing terms.

The staff representatives and messenger/custodian representative shall be elected from among all NTU staff members and messengers/custodians. They shall be appointed to a one-year term and may be reappointed to two ensuing terms.

Student representatives shall be elected in accordance with the rules set forth in the preceding article. Except for representatives of autonomous student organizations, student representatives shall be appointed to a one-year term and may be reappointed to two ensuing terms.

(Convening of the University Council)

Article 38 The University Council shall be convened by the President and shall be convened at least twice each semester.

The University Council shall not meet without a quorum of half its members. If an interim meeting is requested by one-fifth or more of the University

Council members, the President shall convene the meeting within 15 days. Unless otherwise stipulated in the Organizational Charter or the rules of procedure of the University Council, the passage of any resolution made by the University Council shall require an affirmative vote of the majority of the University Council members in attendance.

The rules of procedure of the University Council shall be stipulated separately by the University Council.

(Non-voting attendees of the University Council)

Article 39 The President may invite stakeholders to sit in on University Council meetings as non-voting attendees.

(Roles and responsibilities of the University Council)

Article 40 The University Council is responsible for reviewing and deliberating over the following matters:

1. Planning and budgeting of university development projects
2. Organizational regulations and other important regulations
3. The establishment of, changes to, mergers of, and closing of NTU campuses, branches, divisions, colleges, the Graduate School of Advanced Technology, departments, graduate institutes, degree programs, non-college academic units, research centers, and affiliated organizations
4. Academic affairs, student affairs, general affairs, research affairs, and other important affairs of the University
5. Regulations for teaching evaluations
6. Matters concerning the establishment of committees and ad hoc committees under the University Council
7. Meeting motions and the President's motions

(Establishment of committees and ad hoc committees under the University Council)

Article 41 The committees and ad hoc committees established under the University Council are listed in Appendix 5: Organizational Structure of the Committees and Ad Hoc Committees Established under the NTU University Council.

If deemed necessary, the University Council may resolve to establish or make changes to committees or ad hoc committees to handle tasks assigned by the University Council.

Section II Other Meetings

(Administrative Meeting)

Article 42 NTU shall establish an Administrative Meeting consisting of the President, Executive Vice Presidents, Vice President for Academic Affairs, Vice President for Student Affairs, Vice President for General Affairs, Vice President for Research and Development, Vice President for International Affairs, Vice President for Financial Affairs, Deans of the NTU colleges and the School of Professional Education and Continuing Studies, Head

Librarian of the NTU Library, Secretary-General of the Secretariat, and Directors of the Personnel Office, Accounting Department, and Computer and Information Networking Center. The Administrative Meeting shall be chaired by the President and shall deliberate over matters stipulated in the Organizational Charter and other important administrative matters.

If deemed necessary, the President may invite unit heads, student representatives, or other stakeholders to sit in on the Administrative Meeting.

(College Affairs Meetings)

Article 43 Each NTU college shall establish a College Affairs Meeting to deliberate and make decisions over the college's teaching and research affairs as well as other college affairs.

The composition and rules of procedure of College Affairs Meetings, as well as the matters deliberated over in such meetings, shall be stipulated by the respective colleges and shall be passed by the University Council before implementation.

(Department, Graduate Institute, and Degree Program Affairs Meetings)

Article 44 Each NTU department, graduate institute, and degree program shall establish a Department Affairs Meeting, Graduate Institute Affairs Meeting, or Degree Program Affairs Meeting to deliberate and make decisions over the teaching and research affairs of the department, graduate institute, or degree program, as well as other important affairs related to the department, graduate institute, or degree program.

The composition and rules of procedure of Department/Division Affairs, Graduate Institute Affairs, and Degree Program Affairs Meetings, as well as the matters deliberated over in these meetings, shall be stipulated by the respective department/division, graduate institute, or degree program and shall be passed by the College Affairs Meeting of the associated college and then implemented.

In the event of a dispute between faculty members or other incidents that prevent the effective operation of a Department/Division Affairs or Graduate Institute Affairs Meeting and affect the development of the department/division or graduate institute and/or the rights of faculty members and students, the President may establish a Department Affairs or Graduate Institute Affairs Advisory Board after consulting with the dean of the associated college or the head of the university-level unit. The advisory board shall consist of multiple faculty members in field(s) related to the department/division or graduate institute and will assume the duties of the Department/Division Affairs or Graduate Institute Affairs Meeting until the dispute or incident is resolved.

Regulations governing the establishment of the Department/Division Affairs and Graduate Institute Affairs Advisory Board referred to in the preceding paragraph shall be passed by the Administrative Meeting and then implemented.

(School Affairs Meeting of the School of Professional Education and Continuing Studies)

Article 45 The School of Professional Education and Continuing Studies shall establish a School Affairs Meeting to deliberate over important matters concerning the school. The composition and rules of procedure of the School Affairs Meeting, as well as the matters deliberated over in the meeting, shall be stipulated by the School of Professional Education and Continuing Studies and shall be passed by the University Council and then implemented.

(Center for General Education Meeting)

Article 45-1 The Center for General Education shall establish a Center for General Education Meeting to deliberate over important matters concerning the center. The composition and rules of procedure of the center, as well as the matters deliberated over in the meeting, shall be stipulated by the center and shall be passed by the University Council and then implemented.

(Academic Affairs Meeting)

Article 46 NTU shall establish an Academic Affairs Meeting, consisting of the Vice President for Academic Affairs, Deputy Vice President for Academic Affairs, Vice President for Student Affairs, Deans of the NTU colleges, Dean of the School of Professional Education and Continuing Studies, Vice President for Research and Development, Vice President for International Affairs, Head Librarian of the NTU Library, Director of the Computer and Information Networking Center, Heads of Schools, Department Chairs, Directors of Degree Programs, Directors of Graduate Institutes, Director of the Branch Office of Academic Affairs, Directors of non-college academic units and centers, and Presidents of the Student Association, Student Congress, Graduate Student Association, and college student associations. The meeting shall be chaired by the Vice President for Academic Affairs and shall deliberate over important matters and regulations related to academic affairs.

The Vice President for Academic Affairs may invite unit heads and other stakeholders to sit in on the meeting.

The Academic Affairs Meeting shall be convened by the Vice President for Academic Affairs at least once each semester.

(Committees of the Office of Academic Affairs)

Article 46-1 The Office of Academic Affairs may establish committees for the planning, coordination, improvement, implementation, and assessment of matters related to the University's academic affairs. Each committee shall consist of multiple members appointed by the Vice President for Academic Affairs from among the full-time professors or researchers of NTU.

(Research and Development Committee)

Article 46-2 The Office of Research and Development may establish a Research and Development Committee for the planning, coordination, improvement, implementation, and integration of research resources. The committee shall consist of multiple members appointed by the President from among the full-time professors or researchers of NTU.

(General Education Committee)

Article 46-3 The Center for General Education may establish a General Education Committee to deliberate over and plan NTU's policies on general core, liberal education, physical education, and teacher training courses. The committee shall consist of multiple members (including one student member) appointed by the President.

Chapter IV Academic Ranks and Hiring of Faculty Members and Researchers

(Academic ranks and hiring of faculty members and researchers)

Article 47 NTU faculty members shall be classified into four academic ranks— Professor, Associate Professor, Assistant Professor, and Lecturer—and shall be tasked with instruction, research, and mentoring. The employment of faculty members of different ranks shall be carried out by the President after passage by the faculty evaluation committee in accordance with applicable laws.

NTU faculty members shall fulfill their obligations in accordance with their employment contract and applicable laws and regulations.

In the event of a breach of employment contract or violation of applicable laws, NTU or its associated units may, depending on the severity of the violation, issue any of the following penalties or actions in accordance with the University's *Regulations for the Establishment of the Faculty Evaluation Committee* or applicable laws:

1. Dismissal, non-renewal of appointment, suspension, or severance
2. Suspension of salary raise, suspension of promotion, suspension of evaluation, suspension of eligibility for evaluation exemption, suspension of the right to participate in NTU committees and/or to vote and run for representative office, or suspension of the right to attend and vote in NTU meetings and committees.
3. Denial of extension of service, exclusion from the position of academic advisor, faculty evaluation committee member, or head of administrative unit; or suspension of all benefits offered by NTU
4. Suspension of use of NTU privileges, including the allocation or continued leasing of NTU housing
5. Denial of secondment or adjunct employment/teaching outside of NTU; denial of sabbatical leave; denial of overseas lecture, research, or continuing studies opportunities
6. Other penalties or actions that may be issued or taken in accordance with the law or that are agreed upon in the employment contract

Apart from Subparagraph 1 of the preceding paragraph, regulations for penalties issued or actions taken against breaches of faculty employment contracts or violations of applicable regulations shall be passed by the Administrative Meeting, reported to the University Council, and then implemented.

In addition to the actions described in Paragraph 3, Subparagraphs 2 and 5, faculty members who are currently involved in disciplinary procedures that may result in their dismissal, non-renewal of appointment, or suspension, but who have been temporarily granted a continuance of their appointment may

not receive rewards.

NTU researchers shall be tasked with research undertakings and shall be classified as Research Fellow, Associate Research Fellow, Assistant Research Fellow, or Research Assistant; the employment of researchers shall be subject to the same regulations as faculty members, *mutatis mutandis*.

NTU may organize seminars hosted by professor(s). The regulations for the organization of seminars shall be formulated by the Administrative Meeting, passed by the University Council, and then implemented.

NTU may appoint teaching assistants to provide assistance in teaching and research endeavors. The directives for the employment and management of teaching assistants, and the handling of teaching assistant appeals shall be passed by the Administrative Meeting and then implemented.

NTU may appoint professional technicians in teaching roles. The directives for the employment of professional technicians shall be passed by the Administrative Meeting and then implemented.

(Initial appointments, appointment renewals, and long-term appointments)

Article 48 NTU faculty members, researchers, and professional technicians shall be appointed to one of three categories: initial appointment, appointment renewal, and long-term appointment. Appointments shall be handled in accordance with the principles of fairness, impartiality, and openness.

The initial appointment of faculty members shall be for one year; the first appointment renewal shall be for one year, and subsequent renewals shall be for two years. Non-renewal of appointment shall require review and passage by the related faculty evaluation committee.

Faculty members who have been granted long-term appointment may be appointed until they reach 65 years of age. For units with stricter rules, those rules shall prevail. Long-term appointments shall be made in accordance with applicable laws.

For initial appointments of faculty members, recruitment information shall be published in the mass media or academic publications.

Initial appointments, appointment renewals, long-term appointments, dismissals, suspensions, and non-renewals of appointment of researchers and professional technicians shall be subject to the same regulations as faculty members, *mutatis mutandis*.

(Faculty evaluation committees)

Article 49 NTU shall establish faculty evaluation committees at the university, college, and academic program (department/division, graduate institute, degree program, and non-college unit) levels.

The reasons for the appointment, promotion, suspension, dismissal, non-renewal of appointment, or severance of NTU faculty members shall be reviewed by related faculty evaluation committees.

The rules for the organization and operation of faculty evaluation committees at all levels of the University shall be passed by the University Council and then implemented.

The organization and operation of researcher evaluation committees shall be subject to the same rules, *mutatis mutandis*.

Faculty evaluation committees at all levels may exercise their authority or accept requests from evaluated personnel to grant such personnel an opportunity to state their case.

(Appointments of Professors Emeriti)

Article 50 Colleges, departments/divisions, graduate institutes, and degree programs may recommend the appointment of retired professors with distinguished contributions to teaching and/or research as Professors Emeriti. The directives for the appointment of Professors Emeriti shall be passed by the University Council and implemented.

Chapter V Faculty and Staff Appeals

(Faculty appeals)

Article 51 Faculty members, researchers, and professional technicians who wish to dispute their dismissal, suspension, non-renewal of appointment, exclusion from promotion, or other decisions made regarding their appointment may file a written appeal to the Faculty Grievances Committee.
The regulations for the organization and operation of the Faculty Grievances Committee shall be passed by the University Council and then implemented.

(Staff and messenger/custodian appeals)

Article 52 Staff members who believe that their rights have been affected by inappropriate management practices or measures regarding working conditions at the University may file an appeal with the Staff Grievances Committee.
Messengers and custodians who believe that their rights have been affected by a violation by the University of the *Labor Standards Act* and/or other labor laws may file an appeal with the Messenger/Custodian Grievances Committee.
The regulations for the organization and operation of the Staff Grievances Committee and Messenger/Custodian Grievances Committee shall be passed by the University Council and then implemented.

Chapter VI Student Rights and Obligations

(Student rights and obligations)

Article 53 NTU students shall be subject to the rights and obligations set forth in the *University Act, Enforcement Rules of the University Act*, the Organizational Charter, and other applicable regulations stipulated in accordance with the Organizational Charter.

(Student Counseling Committee)

Article 54 NTU shall establish a Student Counseling Committee to be responsible for amending student affairs regulations, counseling autonomous student organizations and student clubs, and overseeing student rewards and penalties.
The Student Counseling Committee shall consist of the following ex officio

members: the President, Executive Vice Presidents, the Vice President for Academic Affairs, Vice President for General Affairs, Vice President for Student Affairs, Vice President for International Affairs, and Deans of the NTU colleges and the School of Professional Education and Continuing Studies, as well as one faculty member selected from each NTU college, the Department of Psychology, and the Department of Social Work, and the Presidents of the Student Association, Student Congress, Graduate Student Association, and college student associations. The committee shall be chaired by the President or an Executive Vice President appointed by the President.

The Student Counseling Committee may establish committees and ad hoc committees. The regulations for the organization of these committees and the convening of meetings shall be stipulated separately by the Office of Student Affairs, passed by the Student Counseling Committee and Administrative Meeting, and then implemented.

The Student Counseling Committee shall be convened by the President and shall take place at least once each semester.

Meetings of the committees and ad hoc committees mentioned in Paragraph 3 shall be attended by student representatives.

(Student Grievances Committee)

Article 55 NTU shall establish a Student Grievances Committee to handle appeals filed by students, the Student Association, or other autonomous student organizations. The regulations for the organization of the Student Grievances Committee shall be passed by the Student Counseling Committee, submitted to the University Council for reference, and then implemented.

(Autonomous student organizations and student clubs)

Article 56 NTU students may start autonomous student organizations and student clubs at various levels in accordance with applicable NTU regulations. NTU students shall be ex officio members of autonomous student organizations and shall be subject to the rights and obligations set forth in the organizations' charters.

Charters of autonomous student organizations shall be stipulated by each autonomous student organization and will become effective after approval by and acknowledgement from the committees or ad hoc committees established under the Student Counseling Committee.

NTU autonomous student organizations shall elect representatives to participate in or attend the University Council, College Affairs Meetings, Department/Division Affairs Meetings, Graduate Institute Meetings, Academic Affairs Meeting, and other meetings involving student rights in accordance with applicable regulations. The right of students to participate in or attend meetings shall be stipulated by the College Affairs Meetings, Department/Division Affairs Meetings, and Graduate Institute Meetings in their respective organizational regulations.

(Funding of autonomous student organizations and student clubs)

Article 57 NTU autonomous student organizations and student clubs shall be funded through the following sources:

1. Membership dues for autonomous student organizations and student clubs
2. NTU budget earmarked for subsidies
3. Other sources of income

The collection, raising, allocation, and use of the funds listed in Subparagraphs 1 and 3 of the preceding Paragraph shall be carried out in accordance with the charters of the respective autonomous student organizations and clearly stipulated charters of student clubs under the supervision of and audited by the Office of Student Affairs. For funds listed in Subparagraph 2, the Student Counseling Committee shall formulate regulations and submit them to the Office of Student Affairs for administration and auditing.

Chapter VII Campus Security

(Establishment of campus security team)

Article 58 (Revocation of this article approved and acknowledged by the Examination Yuan)

(Maintenance of campus security)

Article 59 Apart from NTU campus security guards, military and law enforcement personnel may not enter NTU campuses without authorization or permission from the President. This restriction shall not apply to officers in urgent pursuit of person(s) in flagrante delicto.

The Regulations for Campus Security Maintenance shall be passed by the Administrative Meeting and then implemented.

(Use of campus venues)

Article 60 Applications to use NTU campus venues shall be made in accordance with the regulations for venue rental and use stipulated by NTU or its units. Regulations for venue rental and use stipulated by NTU units shall be passed by the Administrative Meeting and then implemented.

Chapter VIII Supplementary Provisions

(Administrative neutrality)

Article 61 NTU staff members, messengers/custodians, and heads of administrative units at all levels of the University shall provide support for teaching, research, and services in accordance with the law, and must uphold administrative neutrality in the performance of duties.

(Amendment procedures)

Article 62 Amendments to the Organizational Charter must be proposed by the President or one-seventh or more of the University Council members and receive approving votes from two-thirds or more of the University Council members in attendance in order to be implemented.

(Transitional provision)

Article 63 After an amendment of the Organizational Charter is passed, the related regulations shall be reviewed and amended accordingly.

(Effective date)

Article 64 The Organizational Charter shall be passed by the University Council, submitted to the Ministry of Education for approval, and then promulgated and implemented.
